



Notice of Membership Rate Change

Dear Valued Union County Family YMCA Member,

As we look ahead to 2025 and beyond, we are excited to share how we are continuing to enhance your membership experience with upgrades and improvements that reflect our commitment to providing a high-quality environment, exceptional facilities, and innovative programs that support the health and well-being of our community.

In 2023 - 2024, we completed several improvements across our facilities, including:

- Free Member app (YMCA360) with unlimited wellness and program offerings. Available online or on your phone anywhere you go
- Upgraded Fitness Center flooring and member storage areas
- Pool resurfacing and sealing with fresh paint throughout our pool area
- Upgraded seating on pool deck
- Added Toddler Gymnastics into the facility
- Refreshed the gymnasium area
- New Volleyball Systems with branded padding
- Moved Cycling/TRX into Studio 3 for additional space and functionality
- Structural repairs to building for sustained long term use
- New security system with cameras and monitoring
- Upgraded parking lot and area lighting for brighter, safer member use
- Upgraded Teen Center with new technology, gaming and seating
- Investment in staffing

These improvements have enhanced our spaces and services, and we are committed to continuing these types of upgrades to ensure our facilities remain a welcoming and vibrant hub for our community. Additionally, we continue to invest in our staff to ensure you receive the best experience at every touchpoint—from the membership desk to your fitness classes, and even ensuring safety in the pool. Our dedicated team is at the heart of delivering exceptional service and making your time at the YMCA enjoyable and rewarding.

To maintain this level of investment in both our facilities and our staff, and to meet the increasing costs of operations—such as utilities, supplies, upgrades and staffing — our Board of Directors is in support of this rate adjustment. This will be our first rate adjustment in 10 years.

Beginning January 1, 2025, our new membership rates will be as follows:

Membership Rates:

Youth -	\$30/mth +tax
Young Adult -	\$40/mth +tax
Adult -	\$55/mth +tax
Couple -	\$65/mth +tax
1 Adult and Children -	\$65/mth +tax
2 Adult and Children -	\$75/mth +tax

We do our best to keep membership rates affordable and only adjust them when necessary to continue providing the high-quality facilities, services, and programs you've come to expect. Even with this upcoming change, we remain dedicated to offering value to our members and will continue providing financial assistance to those in need through our Membership For ALL Program.
